Exhibitor Agreement

1In consideration of the receipt of fees established for each booth and/or tabletop, the vendor indicated herein will be provided display space as assigned by the SCTE SoCal Vendor Days Committee. Space assignments will be made based on the order in which applications have been received, with consideration given to those who require locations with power and/or cable drops.

2The SCTE SoCal Vendor Days Committee reserves the right to curtail exhibits or parts of exhibits that reflect against the character of this event.

3Installation and Dismantling. Displays may be installed during the period of 7:00pm to 9:00pm on Tuesday, November 17 and 7:00 A.M. to 9:00 A.M. on Wednesday, November 18, 2009. Exhibit hours for Wednesday will be 9:00 A.M. through 4:00 P.M. and Thursday, 9:00 A.M. through 4:00 P.M. There will be a lunch break each day, during which the exhibit hall will be closed and locked between the hours of 11:45A.M.-1:30 P.M. Dismantling may commence at the close of the Exhibit hours at 4:00 P.M. on Thursday, November 19, 2009 only. PLEASE NO EARLY DISMANTLE.

4Use of Display Space. Each display space assigned herein shall consist of one (1) booth or one (1) tabletop area, unless specifically approved otherwise by the Committee. All demonstrations and distribution of promotional materials must be confined to the limits of your area. No exhibitor shall assign, sublet or share the space assigned without the prior approval of the Committee. Exhibitors are required to keep their space neat and orderly at all times. Exhibitors are liable for any damage caused in any manner to the building walls, floors and covering, which result from actions taken by the exhibitor.

5Hold Harmless Clause. The exhibitor assumes entire responsibility and hereby agrees to protect, indemnify and hold harmless the SCTE, including the SCTE SoCal Vendor Days Committee, the Southern California Chapter, the San Diego Chapter, Desert Chapter and Riker Conference Connection, LLC, their officers and directors, as well as the Doubletree Hotel of Ontario, California and its employees and agents against all claims, losses and damages to persons or property, government charges, or fines and attorney fees arising out of or caused by the exhibitor's installation, removal, maintenance, occupancy, or use of the exhibition premises or a part thereof. The exhibitor understands that neither the Society of Cable Telecommunications Engineers nor Doubletree Hotel Ontario Airport maintains insurance covering the exhibitor's property. It is the sole responsibility of the exhibitor to obtain such insurance.

6Shipping: Exhibitors are responsible for shipping to and from the vendor days. The exhibitor understands that the Society of Cable Telecommunications, its Chapters, the Hotel and RCC are not responsible for any loss or damage to boxes or equipment.
